Dear Sport Association:

Your application has been processed and a permit issued subject to the following conditions:

- Please read your permit thoroughly, checking all locations, times and dates. **Be aware of any exclusion dates on your permit and allow for these in your schedule.** Also, please note the dates that the bookings expire as many fields are being closed for renovation prior to the end of August 2010.
- Sign the contracts and return one copy to my attention at the above address. **The contract is not valid unless it is signed and returned.**
- You must provide proof of a minimum \$2,000,000 Comprehensive General Liability Insurance coverage. The insurance coverage must include and name the "City of Surrey" as an insured party. Your insurance agent must complete and sign the enclosed Proof of Insurance coverage form prior to the start date of your season. Alternately, you may call the office to discuss purchasing insurance through the City of Surrey (information enclosed).
- Please forward a complete list of all registered teams in your organization as well as the names and addresses of all players that are registered on those teams by **June 30, 2010**. It is important that this information be supplied to ensure that we have access to all relevant data that influences future allocations. This request is made to all groups that utilize Surrey sport fields.


Adult Grass & Synthetic Field Usage

- Please notify The City of Surrey of any senior teams (19 years of age and older) in your club that will be using any fields allocated on your permit. These field times will be billed at \$10.51 per hour for grass and \$38.24 for synthetic turf (\$19.13 non-prime). Please submit your senior schedules for play or practices by **April 15, 2010**. **Any Adult teams practicing/playing on Surrey fields must pay the appropriate fees or be subject to penalties that may include a fine.**

- Please notify The City of Surrey of any synthetic turf field time that will not be required for use by your league, prior to **March 31, 2010**. **Any time returned after March 31, 2010 will not be credited or refunded unless the City of Surrey can resell the cancelled time with no loss of revenue.**
- **Payment of permit fees is required by May 1, 2010 or 31 days after the permits are finalized.** Payments may be made in full or arrangements can be made to pay monthly.
